This event, also held on December 4th, has lit up our riverfront with festive lights for the holiday season (north side of State Street on the east side of the river behind the Village Hall). December has been proclaimed "Drunk and Drugged Driving Prevention Month" and I encourage residents to be responsible and drive sober this holiday season. The Village of North Aurora is partnering with the Illinois Department of Transportation's Division of Traffic Safety in an effort to educate residents that Impaired Driving, either by alcohol or drugs, is America's deadliest crime. In the United States, approximately 12,000 people die each year in crashes involving an alcohol or drug-impaired driver. Everyone has a responsibility to drive sober and a right to drive on roadways free of impaired drivers. Please be responsible and let your family and friends know that impaired driving is not acceptable.

As always, I would like to remind residents to shop locally this holiday season to keep our tax dollars within the community. Have a safe and peaceful holiday season.

**Code Enforcement Reminders** - Residents may not dump, shovel or blow snow into the roadway. This slows the snow removal process and can cause dangerous situations. Please remove any portable basketball poles from the curbside to prevent damage to the village's snow plowing equipment. The Village is requesting residents to please notify Code Enforcement (630) 897-1457 x231 regarding vacant structures they may be aware of in their neighborhoods. This will help us to minimize damage that can be caused by broken water pipes in vacant structures. Finally, residents are reminded that vehicles may not be parked on the street after a 2 inch snow fall until streets have been plowed. Violators will be ticketed or towed.

**Police Department - Citizen's Police Academy**

Come join the 8<sup>th</sup> annual North Aurora Police Department's Citizens Police Academy. The academy will held on Thursdays, starting on February 23, 2012, and will run for a total of 10 weeks. It will be held from 7:00 p.m. to 9:30 p.m. at the North Aurora Police Department in the Community Room. Courses cover all aspects of police work. You will learn what police officers really do as opposed to what you see on television. Topics scheduled to be covered:



- Orientation, Hiring procedures, Illinois Vehicle Code
- Patrol Procedures, Criminal Law
- Gang Intervention, Juvenile Law
- Investigations/Crime Scene Processing
- D U I, Practical exercises
- Use of Force/Ride Along
- Graduation

Also planned for this academy, participants will have an opportunity to experience hands-on traffic stop training and simulated firearms training. If you're a North Aurora resident over 18 years of age and would like to learn the truth about police work, participate in the academy. The academies are always free, fun and interactive. This is a great way to forge stronger partnerships between the citizens and the police.

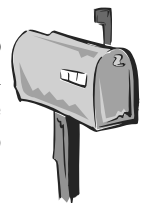
**Public Works News and Information**

Garbage Pickup - Waste Management - Trash pick-up will be on Saturday, December 31st and Saturday, January 7th for those weeks due to the holidays. Please have trash out by 6:00 a.m. as Waste Management will have extra trucks out, which can change pick-up times. Trash pick-up will not be affected by Martin Luther King's Birthday.

Christmas Trees - Christmas trees will be collected free of charge until the end of January, no sticker is required, on regular trash collection days. Christmas trees must be free of all decorations and cannot be in plastic bags. After the free collection period has expired, trees will require one (1) refuse sticker visibly affixed in order to be collected.

Snow Removal - The priority process of plowing streets is based on street usage and levels of traffic. Primary streets will be plowed first, then secondary streets, and finally cul-de-sacs, alleys and dead ends will be plowed last. Residents should be aware of Village Ordinances and related fines of up to \$750 for violations pertaining to snow removal and parking during and after 2 inches of snowfall. Residents should also be aware that snow cannot be pushed, piled, or dumped into streets.

Mailboxes - In preparing for the winter snow season, please be sure that your mailbox is secure enough to uphold the pressure of snow coming off the plow. Mailboxes damaged by the snow coming off the plow will be the homeowner's responsibility. If a mailbox is hit by a snowplow, the Village will repair or replace the mailbox with a standard metal box and a treated 4x4 post. As a reminder, mailboxes should be installed no closer than 9 to 12 inches from the edge of the street or curb.
